

## Spring of Innovation 2023 Participatory Research: Leveraging Inclusiveness

# April 6 and 7, 2023 at Lilliad - Learning center innovation, Campus Cité scientifique in Villeneuve d'Ascq, University of Lille and with remote session

Participatory research is an emerging field in France. The subjects concerned by this research extend to all sectors of activity and in different contexts. With its broad spectrum of questions, approaches and epistemic practices, this field includes various actors from the third sector of civil society. These actors contribute to the different stages of the research process and are at the origin of innovative practices within the social body. The perimeter of stakeholders and their postures in a research project is an important dimension that will be questioned during the symposium.

This conference brings together different currents and practices of participatory research. The capacity and interest of building inclusive research processes will be discussed. By inclusiveness, we mean the propensity to bring together researchers and actors from different backgrounds concerned by a common problem in a desire to co-produce research. It goes beyond mere integration; whose individual nature suggests an adaptation to a given group. In contrast, inclusion places the responsibility for adaptation on the group for each individual. Inclusiveness is situated in this in-between area where the active participation of the actors concerned would be expressed in the whole research process.

This raises a number of questions: what are the contributions, difficulties, impacts or social innovations likely to occur through the broad integration of civil society in scientific processes? What devices and/or mechanisms are needed to match means and ends? In the context of developing the field of participatory research, what are the issues at stake in the inclusiveness of researchers specializing in one discipline? Can we talk about transformation through the social innovation produced in these projects? Does a broader inclusivity allow for a more responsible development of research and innovations?

The program will be structured around plenary sessions and round tables bringing together actors from different backgrounds. Registration to the conference is free. Researchers, associations, representatives of local authorities, doctoral students and post-doctoral fellows are among the audiences targeted by this conference.

The notion of inclusiveness lends itself to two opposing interpretations: either all stakeholders contribute to all stages of the project, or each stakeholder makes a distinct and complementary contribution. What both perspectives have in common is that all are bound by the same purpose and level of commitment. A PAR vision that is better suited to complex situations and systems promotes "variable geometry inclusiveness"-serving as a convergence point for multiple initiatives and cross-cutting conversations.

#### Inclusiveness in research: an end in itself or a means for other purposes?

The inclusion of relevant audiences in research and innovation processes can have two complementary objectives. Inclusiveness as an end in itself refers to the idea that citizen participation in the production of knowledge is one of the engines of democracy. Inclusiveness as a means for other purposes makes the participation of relevant groups the key to more equitable and correcting research and innovation processes. The thesis I would like to defend is that participatory research, in its various forms, is only a partial answer to the second issue. Certainly, the pragmatic current takes a radically co-productionist position, the groups concerned and the problems forming in the dynamics of the collective investigation/experimentation polarized towards the search for solutions. This position inspires the dialogical model proposed by Michel Callon, Pierre Lascoumes and Yannick Barthe in Agir dans un monde incertain. That is an essential element. Nevertheless, on the basis of the lessons of the political economy of research and innovation -and in particular the recent literature on Undone science- we suggest that it is necessary to broaden the focus in order to consider institutional levers of inclusiveness, in the worlds of research but also in the third sector of research.
